**The transfer of dogs to Svalbard** (is regulated by Forskrift om forbud mot innførsel av dyr til Svalbard (Regulations prohibiting the import of animals to Svalbard) FOR 1988-08-31 nr 744).

- You need a valid **import permit** from the Norwegian Food Safety Authority.
- The dog must be accompanied by a valid EU/EEC passport, or a health certificate if it is arriving directly from territories outside of the EU/EEC.
- The dog must be identifiable by microchip or tattoo.
- The dog must be vaccinated for rabies. It must be vaccinated against rabies in accordance with the vaccine manufacturer's directions.
- The dog may not travel to Svalbard prior to a valid blood titer test showing that it has a titer level of at least 0,5 IE/ml. The blood titer test cannot be taken earlier than 30 days after the primary vaccination course and must be documented in the dog's passport (by an authorized veterinarian in the EU/EEC) or a health certificate (by an authorized/official veterinarian in its homeland outside of the EU/EEC).
- The dog must be vaccinated for canine distemper and treated for ectoparasites (for example, fleas and lice). The treatment must be documented in the dog's passport. The treatment must be performed 1-21 days before travel to Svalbard and be certified by a veterinarian.

**Transfer of pets <u>from</u> Svalbard to Norway/ EU** (is regulated by *Forskrift om ikke-kommersiell forflytning av kjæledyr- Kjæledyrforskriften—the Regulations on non-commercial movement of pets).* 

When you take your pet from Svalbard to Norway, you are passing the outer boundary for the EU/EEC. Written permission is not required, but you must show the animal and necessary documentation to customs officials/the Norwegian Food Safety Authority. If you are traveling to or through Tromsø, you must inform the Norwegian Food Safety Authority at the latest 2 business days before travel by phone, 22 40 00 00, or email <u>GK\_Tromso@mattilsynet.no</u>. Passenger screenings for travelers to or through Tromsø via plane will be conducted after check-in at the Svalbard Airport Longyear in cooperation with Widerøe Ground Handling from October 1<sup>st</sup>, 2021.

It is important that you have a thorough understanding of the regulations. ## If the dog is taken on to other countries and then shall return to Norway:

This is regulated by the Forskrift om ikke- kommersiell forflytning av kjæledyr-Kjæledyrforskriften (The regulations for non-commercial transport of pets). The requirements for reentry depend on whether the dog has been to an EU/EEC country or other countries.
